Transition Team Report

Large Church Staff Conference

On Wednesday, November 9 and Thursday, November 10 the Professional Staff participated in the Unitarian Universalist Association's Large Church Staff Conference. The theme of the conference, The Community of Communities: A UU Growth Mindset, offered an opportunity for staff across the country to connect with others with similar roles in different congregations. The presentations were led by Dr. Paula Cole Jones. Dr. Jones is the founder of ADORE (A Dialogue on Race & Ethnicity), a former president of DRUUMM (Diverse and Revolutionary Unitarian Universalist Multicultural Ministries) and an independent consultant specializing in multicultural competencies and institutional change.

This is the first time this conference has been offered virtually, so it presented a unique opportunity for the full-time staff to connect with other large congregations who are seeking ways to encourage growth and connection during a time of rebuilding and transition. Focusing on the concept of creating communities within our community to help foster connections, congregations were asked, how do we enact a shared ministry? How can we create communities within our community that foster connection and a culture that suits their needs and still covenant with the larger mission and vision of the congregation?

We also discussed Vision. We were asked do we have a compelling Vision? Does the community believe in it? Are our actions aligned with our Vision? And finally, have we positioned our Vision in the organization to be sustainable and "marketable"? All of these questions are important and timely given the work ahead of our community.

There wasn't an attempt to answer these questions, but they are what we will need to ask and answer ourselves as we lean into this transitional work. They will also help frame the work we will embark on with a growth mindset.

One of the most impactful aspects of the conference was the ability to join other congregational staff with similar roles to discuss successes and challenges during this time. One of the common successes included key volunteers stepping up. Some of the common challenges included stewardship/finances, informal power struggles and low attendance among families with children. As a staff we plan to take the knowledge gleaned from this conference and use it to help frame our pathway forward.

Membership/Participation

As of October 31, 2022, UUCC membership is at 568. We have added 15 new members and removed 17 so far this congregational year. Approximately 46% of members were recorded as participating in the life of the congregation. Service attendance was an average of 164 per service, down from 177 in September and 189 in August.

This year's campaign varies slightly in that we group former monthly pledge groups into three separate campaigns: "Fall" (formerly September through November), "Winter" (formerly December through February) and "Spring" (formerly March through June). By combining months, we'll be able to streamline our efforts and provide additional time for communicating with members.

The campaign kicked off in September. The months of September and October were about communication and celebration. Pledge packets were mailed, and canvassers reached out to members for conversation and connection. The Baxter family (Ben, Gillian, Anna and Connolly) sent a special message to the congregation about what the UUCC means to them followed by a Fall potluck on Saturday, September 24. Twenty-eight members gathered and enjoyed food, conversation and games. On October 2nd, team member Joy Bruce gave an appeal from the pulpit. The Share the Plate campaign began on October 23 and ran through Sunday, November 13. Thank yous will be sent mid-November.

Despite all our efforts, total pledges from the Fall Group saw a net decrease with six member units increasing and 21 decreasing. Although this is disappointing news, we have had an influx of new members in the last quarter which has helped offset some of the decreases. We are down \$10,811 so far for the year. The Winter group campaign begins December 1^{st.} We will continue to focus on communication, connection and

celebration that will continue to include more special messages, canvassing, a Share the Plate campaign and a Winter Potluck on Saturday, January 7.

Ongoing Activity

This report includes some changes to our teams. Family Ministry and Community Building are now combined. Our goal is to have mostly intergenerational events rather than to regularly segregate those for families. Also included in this report is a new team: Denominational Relations. Our preliminary goal is to strengthen UUCC's connection to Unitarian Universalism.

Adult Education/Spiritual Development (AESD)

submitted by program coordinator, Linn Martin AE/SD presented a variety of programs since the October 12 report.

October 13 & 20: The Climate Justice/GreenFaith Circle Program held its third and fourth meetings, wrapping up with the formation of a UUCC GreenFaith Circle. Total attendance for all four meetings was 71 people. The new circle is currently being led by Richard Pratt and Margie Storch, but they are looking for people to take leadership roles. Amy Brooks Paradise joined us for the final session, adding a great deal of credibility and enthusiasm to the start-up process. Monthly meetings will be held the second Monday evening of each month. It is my understanding that the circle will fall under the Intersectional Justice Team.

October 27 & November 3: The Big Questions program, facilitated by Rev. Lisa, was a very well-attended program. Total attendance for the two sessions was 44 participants, and it was clear at the wrap-up that the attendees hope for more of these reflective programs.

Monthly Discovery Circles: We were pleased to reintroduce the practice of Discovery Circles this year. We had intended to limit the circles to just one this year due to the difficulty of finding willing facilitators. We had 14 people sign up, and at the midnight hour, were able to rally two more facilitators; in addition to Suzanne Lake and Susan Hill, Camilla Mazzotta and Michelle Dillon were kind enough to step up to the plate.

November 10: Credo Writing Workshop. Carol Hartley will facilitate the workshop, which currently has seven registrations.

November 12 & 19, December 3: A three-part Introduction to Tai Chi on Saturday mornings. This program will be led by Charles Lee, husband of AE/SD team member Kristin Rogentine Lee. This program is open to high school age and adults, and weather allowing, will be held in the 234 parking lot; alternatively, Freeman Hall.

Monthly Credos: Barbara Devinney, who voluntarily replaced Carol Gay as the coordinator, is off to a excellent start. She has already confirmed three presenters for early in the coming year and is actively pursuing a mix of ages, genders, and other diversities. Credos are by the biggest draw of the AE/SD programs so we are relieved and happy to see the program reinvigorated.

A new affinity group was established under the AE/SD umbrella – Writing Your Spiritual Journey. This group is being led again by Marsha Kelly and will be a closed group limited to ten people, meeting monthly at 234. It is my understanding this is generally a resurrection of a former close-knit group of individuals from pre-covid times.

In early December the AE/SD team will meet to form plans for the first half of 2023. Our first five months have provided helpful information in terms of logistics, interests, and program responses, and we will surely draw upon our experience as we move forward into a new year; of course, suggestions are always welcome!

Sunday CYRE Classes: We have continued steady attendance in CYRE classes. Our High School class attendance remains smallest; SpiritPlay, Elementary and Middle School classes continue to be well-attended.

Some of the elementary class met to attend a Shabbat service on Friday, November 4 at Temple Beth El, as a part of the World Religions curriculum. Those unable to attend had the option to watch via live stream or the recorded service later. We hope to fit in one more visit to a different house of faith before the end of this year, with more in the spring.

The Middle School outing to the Davidson Challenge Course on Sunday, October 30 was attended by 13 youth, along with three advisors, and went very well. Several youth also

joined the Middle School Youth Group in attending a Corn Maze on the evening of Friday, November 4.

The High School class has been working hard to prepare their upcoming November 13 service, with the theme "Self-Examination in a Prejudiced Society."

The Pancake Breakfast fundraiser was on Sunday, October 23 following service. A joint effort by both the Middle and High school classes, it was a success—raising over \$600 for the Boston Trip.

Nursery: attendance is light, but consistent.

CYRE Team: The next monthly meeting will be held on November 20, via zoom, with planning for the upcoming "Crafts with Santa" event on December 10 being the main focus.

Mountain Cons: The Middle School Mountain Con is November 18-20 and has eight youth going. Registration for the later Elementary and High School Mountain Cons is light so far but will hopefully increase as the deadline approaches.

Our Whole Lives (OWL): The first weekend of two Sr. High OWL sessions was held on Friday eve through Sat, Nov 4-5. There will be one more weekend session in Mid-December. The other two OWL offerings, 5th-6th and 8th-9th grades, will run in the Spring.
