Coordinating Team Report to the Board of Trustees June 2023

The Coordinating Team (CT) brings the following items to the Board for your attention and awareness:

Employee Retention Credit

In December of 2022, we received notification from our payroll company ADP that we qualified to amend our taxes to receive the Employee Retention Credit. According to IRS.gov, the Employee Retention Credit (ERC) is a refundable tax credit for businesses that continued to pay employees while either shut down due to the COVID-19 pandemic or had significant declines in gross receipts from March 13, 2020, to Dec. 31, 2021. Eligible employers can claim the ERC on an original or adjusted employment tax return for a period within those dates. Quarters in which you received a PPP loan are ineligible.

ADP amended our payroll tax filings for the qualifying quarters in December. These amendments were made for both the UUCC and Open Door School combined since we share a Tax ID number. In early June, the UUCC and Open Door School received two tax refunds for quarters January 2021-March 2021 and April 2021-June 2021 totaling \$93,000. We are now expecting additional tax refunds for four additional quarters.

The news has been reported to the Finance Team and Open Door School. We are now working with ADP to determine the division of funds between UUCC and Open Door School. Preliminary recommendations from the UUCC Finance Team include covering four immediate expenses (tree mitigation work-see request below, repair and rebuilding of two windows in the educational wing, replacement of five aging toilets at 234 and two new work terminals.) The projects total less than \$13,600. The team recommends that the remaining proceeds for the UUCC be allocated to reserves.

Request for Authorization to Commit Reserve Funds

On Wednesday, June 14, Arborist Matthew Hanson did his annual survey of the trees at 234 and found that we have one dead hickory tree (located in the planting area on the traffic circle playground.) He also found several large diameter dead limbs over the

playground near the parking lot. It has been suggested that the dead tree and the removal of the dead limbs are done immediately since they pose a safety issue.

Preliminary recommendations from the UUCC Finance Team include covering four immediate expenses (tree mitigation work-see quote above (\$4900), repair and rebuilding of two windows in the educational wing (\$2500), replacement of five aging toilets at 234 (\$4000) and two new work terminals (\$1500.) The projects total less than \$13,600. The team recommends that the remaining proceeds for the UUCC be allocated to reserves. A copy of the proposals can be found <u>here</u>. New Coordinating Team's Report to the Board Schedule

As summer vacation starts, member participation often slows down. Though our raw membership number has continued to decline, we are noticing younger members and families participating and joining. The five members joining since May 1 are all under 45 and have children at home. Community Sundays

Our workshops for May included a handbells workshop, a scavenger hunt in our gardens, a song swap workshop with guest speaker Rev. Sara Dendy-Green and a lectio divina. Again, we had some visitors tell us they attended specifically because it was Community Sunday. Every offering was at least somewhat intergenerational.

From feedback questionnaires, these experiences were rated an average of 4.64 out of 5! They also got high scores in the areas of fellowship, intergenerational community building and spiritual growth. The lowest scores were in the areas of justice and democratic process. We do recognize that some people do not attend Community Sundays. Feedback has included that we have not offered experiences that are of interest to them or that they do not want to participate in intergenerational community. We will continue to experiment with offerings and seek input from the community.

We will skip Community Sunday in June since it conflicts with the scheduled bridging/family dedication service. We will resume in July. We are grateful to this planning team and to the many volunteers who facilitate the workshops that make these experiences possible.

Overall, the Adult Education & Spiritual Development Team was successful in its endeavors to hear and respond to our community's concerns and interests. By keeping a focus toward the four priorities identified in our survey earlier in the year (spiritual development, racial equity, environmental issues, and art/film/music), we were able to offer a wide variety of programs that engaged a broad expanse of the adult population of UUCC in both educational and spiritual development opportunities.

The team is preparing to transition leadership from program coordinator Linn Martin to incoming DLRE Paula Gribble. Upcoming CREDO presentation will be Joe Spencer. The four-session UU Wellspring series offering a deep dive into UUA's Proposed Article II bylaw amendment is wrapping up.

The building and grounds team met on June 1. At this meeting we finalized the work plan for the repair work to the wall that runs parrel with North Sharon Amity Rd in the educational wing. We also discussed the outstanding projects on our agenda.

On Sunday, June 4th, Eagle Scot Cole Gilman, members of his troop and other volunteers began their work on the planting area next to the playground near the traffic circle. As a reminder, Cole and other volunteers are working to revitalized the area that was created as an Eagle Scout project for former member Dan McCready. The project is scheduled to be completed by the end of the month.

On Saturday, June 11th the new awnings were installed over the main entrances at 234. The awnings have been an expressed need for some time now and we are pleased to finally have them in place. This work is possible due to the grant program of the Memorial Endowment Trust (MET) of the Unitarian Universalist Community of Charlotte. The generous support of our members allows the Memorial Endowment Trust to make grant funds available to the UUCC on an annual basis.



On Wednesday, June 14, Arborist Matthew Hanson did his annual survey of the trees at 234 and found that we have one dead hickory tree (located in the planting area on the traffic circle playground.) He also found several dead limbs over the playground near the parking lot. In addition, he also suggested that we prune some of the limbs away from the roof. In the past fallen branches have caused compromises in our rubber membrane roof and they serve as a "highway" for rodents and pests. It has been suggested that the dead tree and the removal of the dead limbs are done immediately since they pose a safety issue. We are requesting reserve funds to cover the cost of this emergency expense (please see the request to use reserve funds in this report.)

Finally, we want to thank Virginia "Jinny" Sullivan for her tenure on the building and grounds team. She has truly been a valuable asset to the work of the team.

Our current monthly schedule has children and youth in service for the first (approximately) fifteen minutes on First Sundays and all ages together for the full (short) service for Community Sundays on Third Sundays. We will continue to do periodic full multigenerational services. The intent is to do them approximately quarterly, but we have found that it makes more sense to choose all ages services based on topic rather than timing. Things like the water ceremony in August, ancestor remembrance in October, and Martin Luther King, Jr. Day in January have traditionally been multigenerational.

The team has given most of its focus this month to supporting summer services. Rev. Lisa will be out of the pulpit from June 25-July 29 while services are led by a combination of outside guest speakers and UUCC lay leaders. Gratitude to the Membership Team and a subset of the Worship Team for planning and leading services over the summer. We are also implementing a "host" role, filled by a Worship Team member, who will greet pulpit guests and help them get oriented in Rev. Lisa's absence.

We have welcomed Sarah Kucharski to the team (among others for the new fiscal year). Sara has begun working with Rev. Lisa to learn how to create the slides and tech script in addition to regular worship team duties.
