Transition Team Report

This month, the interim focus has been largely on supporting the congregation in practicing healthy conversation while engaging the conflict in the UUCC members facebook page. The transition team has supported Rev. Lisa by listening and giving feedback regarding potential response. In addition, members of the team attended the meeting after the service on 1/8.

During the acute phase of this conflict, there was much communication between the board and Rev. Lisa (on behalf of staff) regarding the appropriate roles of each group (board of trustees and staff) under policy governance. It is understood by both parties that the board's role is vision and monitoring while the staff's role is implementation of ends and interpretation of policy. In the context of the interim work, this situation is an effective "case study" (albeit live and in person rather than in the abstract!) that has supported broader understanding of these roles and accountability.

Rev. Lisa expresses her gratitude to the board for their support of the staff's role and authority regarding the moderation decision made in the Facebook group. In particular, the understanding that it isn't the board's role to agree or disagree with the outcome of the policy decision, but to ensure that the process that led to the decision was in line with the agreed upon policy and enacted in good faith.

In coming months, Rev. Lisa will be hosting a series of drop-in "sack lunch" or virtual conversation sessions. These will be informal meetings to encourage fellowship between UUCC members, and increase opportunities for in-person communication.

income of \$426,940 was below budget by \$13,629. Looking at giving trends over the last three years (2020-2022) by mid-year we have collected approximately 53% of our annual income. As of December 2023, we have collected 52% of projected income.

We continue to underspend in programming. Year to date expenses are favorable to budget by \$27,348.

Mid-year finds us with a net income of \$41,154.

Six months into our congregational year, contributions (non-pledged income) and Other Income continue to trend well above budget due to increased contributions, rental receipts and interest earned on certificates of deposit. Pledge payments continue to be below budget by approx. \$26K. We will continue to send pledge statements on a regular basis to remind members of their outstanding balances, and hopefully close the gap on lower than projected pledge income.

We will continue to monitor income and spend conservatively as possible.

Current Programming: ARESD offered the Common Read class in October, and it was well attended and received. We are going lead a service on February 4 to share what was meaningful about the class with others. We may do a second round of this class if there is interest.

In February, we will offer a class called "What About All These Words?" The class will examine religious language. It will be offered as two options: a 1 session/in person Saturday morning, and a 2 session/Zoom Thursday evening. If the class is well received, it is likely to develop into a series.

We are looking at other class options to add.

ARESD Team: ARESD has had two wonderful and productive meetings. We looked at past strengths and challenges of programming, and what folks thought UUCC needed in Adult Programming. The ARESD team and the DLRE have taken on the responsibility for Credo and Discovery Circles.

Credo programming is in process. We have created a nomination form for others to suggest folks they might want to hear from. ARESD is working on guidance around Credo presentations and recruiting speakers.

Discovery Circles is the next concentration for the Team. DLRE and Ron Spake will work together to look at what has been done in the past and develop a plan to re-launch them.

Future Plans/Big Picture: DLRE, along with the ARESD Team, have identified two trajectories for Adult Learning and Spiritual Growth. 1: Classes which look at Religious Origins, and work toward healing religious trauma, and 2: Classes which center on relationship, seeking healthy ways to connect and deal with conflict.

The second quarter of our congregational year for the Building and Grounds team has been relatively quiet. The team has focused on assisting in getting some much needed projects completed. The team discussed proposals for the removal of a dying tree with the work being completed in December. Select members of the team held several meetings with stakeholders of the Congregational Care Team to explore expanding the memorial garden and the dis(Ability) group to discuss adding ramp access to the Sanctuary stage.

Landscape lighting was installed in November. Additional lighting has been an expressed need, especially since the installation of our firepit. Although there is one remaining installation phase, most of the work is complete. A special thanks goes to Eric Smith and the volunteers of the Building and Grounds Team! This work is possible due to the grant program of the Memorial Endowment Trust (MET) of the Unitarian Universalist Community of Charlotte.

For the winter months, the gardening group is moving their work indoors. Their plan for the next few weeks is to focus on planning. Jean Wilson, head of the gardening group, says, "the group is going to look at each area and draw landscape plans showing what is already there, and what, if anything, we can/should add, move or rearrange." The goal is to have plans in place for spring. These meetings will take place during their usual meeting times on the 2nd and 4th Saturday in the Conference room between 1-4 p.m. Any gardening volunteer is welcome to attend.

•Children, Youth, and Families (CYRE)

Data: We currently have 78 children and youth registered. Average Sunday attendance is 28. December was a hard month with the holidays as well as Paula struggling with health issues. There are 12 Class Days from January – June.

Note: We need to find a way to count attendance for multigenerational services. Also, not all attend on Sunday mornings but attend other things, and not all who attend on Sundays come every Sunday. We now refer to "Middle School Youth" as "Jr. Youth" (Grades 5-7), and "High School Youth" as "Sr. Youth" (Grades 8-12).

Sunday Programming: Classes continue to go well. There was a break from classes Dec. 10 – January 7 for multigen services and holidays. Classes begin again on January 14.

The Sr. Youth will be doing their worship service on February 11. They will have a lock-in (overnight at church) to plan the service on January 12. Rev. Lisa will meet with Youth to help them plan.

We are seeing steady attendance in classes, and good attendance in other activities. Children seem to be enjoying things like children's choir and Community Sunday. We continue to find ways to engage the Youth on Sundays.

CYRE Team: The team has been an extreme support to the DLRE, particularly stepping up to help when Paula was ill. The Team has recently assisted with events, holidays, and Our Whole Lives (OWL) work.

In addition to vision work and big picture planning, the Team has chosen portfolio areas (such as OWL, Events, Curricula, etc.) for subgroups to work on.

Other Events: The holidays brought great fun for children and families. Many people attended the Holiday Party on December 16 where they visited with Santa and enjoyed games and crafts. Around 20-25 children attended and participated in the Christmas Eve service and pageant.

In December, UUCC wrote and mailed holiday messages of hope and care to 100 incarcerated Unitarian Universalists through Church of the Larger Fellowship's Worthy Now Prison Ministry.

In November and December, members from Denominational Relations and Intersectional Justice participated in a pilot WEAV (WEAV stands for Who and What are UUs? Embodied Justice, Advocacy, and Vision) training offered by Starr King School for the Ministry. Participants offered feedback to the class leaders to help improve the final offering. This month, the same participants will attend additional facilitator training so that this program can be offered at UUCC in the future.

Next month, UUCC will certify with the Unitarian Universalist Association, submitting our congregation directory listing, congregational leadership, financials, membership, diversity, etc.

Upcoming activities for this team will include preparing the congregation to participate in General Assembly (virtual this year) and partnering with UU Justice NC and UU the Vote regarding the 2024 elections.

• Music

The late fall/early winter music program had robust attendance in the Adult and Children's Choirs, with the Handbell Ensemble staying consistent. Since the October 11 report, the Adult Choir sang in eight services, the Soprano/Alto Ensemble (a subset of the Adult Choir) sang in two services and the Children's Choir sang in three services. Highlights included the children singing for a Halloween-themed service on October 29, and the Handbell Ensemble and Adult Choir presenting a seasonal Music Sunday in early December. On December 24, the Children's Choir sang in the 4:30 p.m. service and the Adult Choir sang in the 7:00 p.m. service, accompanied by a brass ensemble comprised of UUCC members.

Members of the Adult Choir, accompanied by Scott Whitesell, sang an outreach holiday concert for a large and appreciative audience at Brookdale Carriage Club on December 3. Several residents there have been UUCC members. An afternoon of caroling to homebound UUCC members on December 17 had to be cancelled due to very wet weather, but John Herrick met with the members and delivered care packages from the Congregational Care Team. Singers from the Adult Choir will take a Singing Valentine program to Brookdale Carriage Club and Windsor Run on February 11 (past UUCC members live at both locations).

Community building social activities included monthly pre-rehearsal dinners for the Handbell Ensemble on the second Wednesday of each month, a post-rehearsal reception for the choir on November 1 and a Twelfth Night potluck gathering for all music program participants on January 6.

Music team member Jan McNeely did a wonderful job this past fall in organizing the UUCC music library and will continue to serve as music librarian.
